The unemployment rate held steady at 7.4 percent in January, reflecting sluggish economic growth.

Canada's negotiating position, which will be tabled at multilateral trade talks in Geneva in the next ten days, will call for a substantial reduction in the level of subsidies and complete elimination of export subsidies by all nations.

Countries support their farmers in three ways: through domestic farm programs, through border protection such as tariffs and import restrictions, and through export subsidies that help their farmers compete on the world market.
