The legal profession attempts to meet the needs of clients regarding language preferences; however, there are certain limitations. Most lawyers are cognizant of ensuring that the usage of gender-inclusive personal pronouns such as *they* (plural) in place of *he* or *she* (singular) does not detract from the intended meaning of, or references within, legal documents.
